# **Viewfinders of Romsey Camera Club**

# Constitution

December 1998 (updated July 2023)

- 1. Name. The name shall be "Viewfinders of Romsey Camera Club".
- 2. Club Year. The Club's activity year will be 1st September to 31st August.

#### 3. Objective.

The objective of the Club is to encourage its members to enjoy their hobby in all its aspects without sectional interests taking any form of preference, thereby enabling all members to get more enjoyment from photography.

# 4. Membership.

Any person interested in or practising photography as an amateur or professional who agrees actively to support the Club's objectives may apply to the Hon Secretary for membership. Acceptance of Membership applications is at the discretion of the Club committee.

# 5. Subscriptions.

Subscriptions are to be agreed annually at the AGM or by a Special General Meeting. Subscriptions shall become due on 1st September each year. Those members who have not paid their subscriptions by 31st October will be unable to participate in Club activities or use the Club's name in connection with their work until such time as their subscriptions are paid up to date.

#### 6. Administration.

Administration of the Club will be handled by a committee elected at the Annual General Meeting. The committee will consist of the Chair, Secretary, Treasurer and up to nine other members. Specific committee duties will be decided and notified to Club members by the committee from time to time.

If required, the committee may co-opt committee members from the current membership of the Club, to support its administration until the next general meeting.

#### 7. Annual General Meeting.

The AGM is to be held normally at the last Club meeting of the Club year. At the AGM all the committee members are due for election.

The business shall include:-

- 1) Minutes of the previous AGM.
- 2) Annual reports by the Chairman and Committee.
- 3) Independently examined statement of accounts and balance sheet.
- 4) Election of officers and committee members.
- 5) Appointment of Independent Examiner and Southern Counties Photographic Federation delegates.

## 8. Special General Meeting.

A Special General Meeting can be called at any time by the committee or on receipt of a requisition signed by not less than 25% of the members. Twenty one days notice must be given to all members of any Annual or Special General Meeting, with particulars of all business to be transacted. No business other than that appearing on the notice/agenda shall be transacted.

#### 9. Nominations.

Nominations for committee members shall be accepted from fully paid-up members and seconded and must be signed by the nominee who must also be a fully paid-up member. Nominations will be accepted up to and at the AGM.

#### 10. Propositions.

Propositions for the AGM and Special General Meetings shall not be accepted unless given to the Secretary in writing at least 14 days before the date of the meeting, signed by two members as proposer and seconder.

# 11. Competition and Monthly Assessment Rules.

A copy of the Rules shall be available on the Club's website. Any changes to the Rules shall be formulated by the Committee and notified to the members.

# 12. Committee Regulations.

Committee members shall receive at least seven days notice for meetings other than club night meetings.

#### 13. Minutes.

The minutes of committee meetings shall be recorded and a copy emailed to club members.

#### 14. Accounts.

A full and accurate account of finance shall be available at all times.

#### 15. Insurance.

Adequate Club insurance must be maintained.

#### 16. Unforeseen issues.

In the event of anything occurring not provided for or not clear in this Constitution, the Committee shall have the power to deal with the same at their discretion.

# 17. Dissolution.

- 17.1 The Club is a non-profit making organisation. All profits and surpluses will be used to support, improve or develop the Club's activities and facilities, or to carry out the objects of the Southern Counties Photographic Federation to which it is affiliated. No profit or surplus will be distributed other than to another non-profit making body on a winding-up or dissolution of the Club.
- 17.2 The Club may be dissolved only with the consent of 75% of the members present at a Special General Meeting called for that purpose.
- 17.3 If, upon the winding up or dissolution of the Club there remains after the satisfaction of all its debts and liabilities any property whatsoever, it shall be transferred to some other non-profit making organisation or organisations having objects similar to the objects of the Club, such organisation or organisations to be determined by the members of the Club by Resolution passed at a General Meeting or in the absence of such a resolution to the Federation to which the Club is affiliated.

## 18. Constitution.

A copy of the Constitution shall be maintained on the Club's website. No alteration to this constitution shall be made except at an Annual General Meeting or a Special General Meeting.
